 - Diverse systems have been designed and installed throughout the region
 - Each customer has specific needs
 - Most projects are treated as custom

New Construction Projects

- Get Eversource involved early
- Is the project a new building?
- Is the project a new process?
- Is the project replacing existing equipment?

Retrofit Projects

- Get Eversource involved early
- Is the project a retrofit on an existing process?
- Can we put controls on existing equipment?
- Are there other measures that we can include?

New Construction Incentives

- Different pathways depending on type of project
- New equipment based on incremental cost/savings
- Multiple measure incentives available



- Incentives based on installed costs/savings
- Incentives improved based on multiple end uses
- A great opportunity to use studies to maximize incentives
