## MICHIGAN DEPARTMENT OF ENVIRONMENT, GREAT LAKES, AND ENERGY (EGLE) IPP PER- AND POLYFLUOROALKYL SUBSTANCES (PFAS) INITIATIVE

- WWTP with required IPP Program
  - Identify Industrial Users with potential PFOA and PFOS sources
  - $\circ$  Sample probable sources
  - Require source reduction at confirmed sources
  - Monitor compliance and submit reporting

- Biosolids Interim Strategy Results
  - Source control is highly effective at reducing elevated concentrations
  - Overall PFOS and PFOA concentrations in effluent discharges and biosolids are decreasing
  - 90% biosolids in Michigan fall below mitigation threshold
  - No facilities with biosolids above industrially impacted threshold since 2021
