

DIVING INTO PUBLIC NOTIFICATION OF CSO ACTIVATION—PART 2

Communities with combined sewer overflows (CSOs) are increasingly faced with regulations that require extensive reporting and public notification steps whenever a CSO discharge occurs.

The NEWEA CSO/Wet Weather Committee is sponsoring its second webinar on this subject to assist CSO communities in understanding these requirements, assessing possible impacts, and provide a variety of strategies for designing their own CSO notification programs.

This webinar will focus on three New England CSO notification programs (the Hartford Metropolitan District (MDC), Boston Water and Sewer Commission (BWSC), and the Narragansett Bay Commission (NBC)) that use public-facing websites to report real-time CSO data. We will also discuss the new Massachusetts CSO Notification Rule (January 2021). Our webinar will finish with a round table discussion of CSO notification program challenges with speakers from both of our webinars.
