CHATHAM WATER POLLUTION CONTROL FACILITY AND PUMP STATION

The tour of the Chatham Water Pollution Control Facility (WPCF) and a nearby pump station will highlight the sustainable design and specialized nutrient removal that were implemented to accommodate the highly seasonal flows and very strict effluent limits.

The WPCF was upgraded in 2011 and is currently achieving an effluent annual average total nitrogen of less than 3 mg/L. The WPCF is the first wastewater treatment facility to be issued a groundwater discharge permit with nitrogen requirements at the limit of technology in Massachusetts.

The upgrades are part of the initial implementation of the Town's Comprehensive

Wastewater Management Plan (CWMP) that was completed in 2009. The CWMP called for two thirds of the town to be sewerized to meet the nitrogen TMDLs. Both the WPCF upgrade and initial collection system projects received funding from the American Recovery and Reinvestment Act (2009).

Chatham is the first community in Massachusetts to complete a CWMP for non-point source nitrogen Total Maximum Daily Loads (TMDL) compliance. They also became the model community for the development of a flow neutral bylaw, allowing the Town to become eligible for 0% loans through the 2008 Environmental Bond Bill. They also developed the first Adaptive Management Plan for a non-point source CWMP. The Chatham CWMP project was the winner of the Environmental Engineering Excellence (E3) Award in 2011 from the American Academy of Environmental Engineers in the Planning category.
